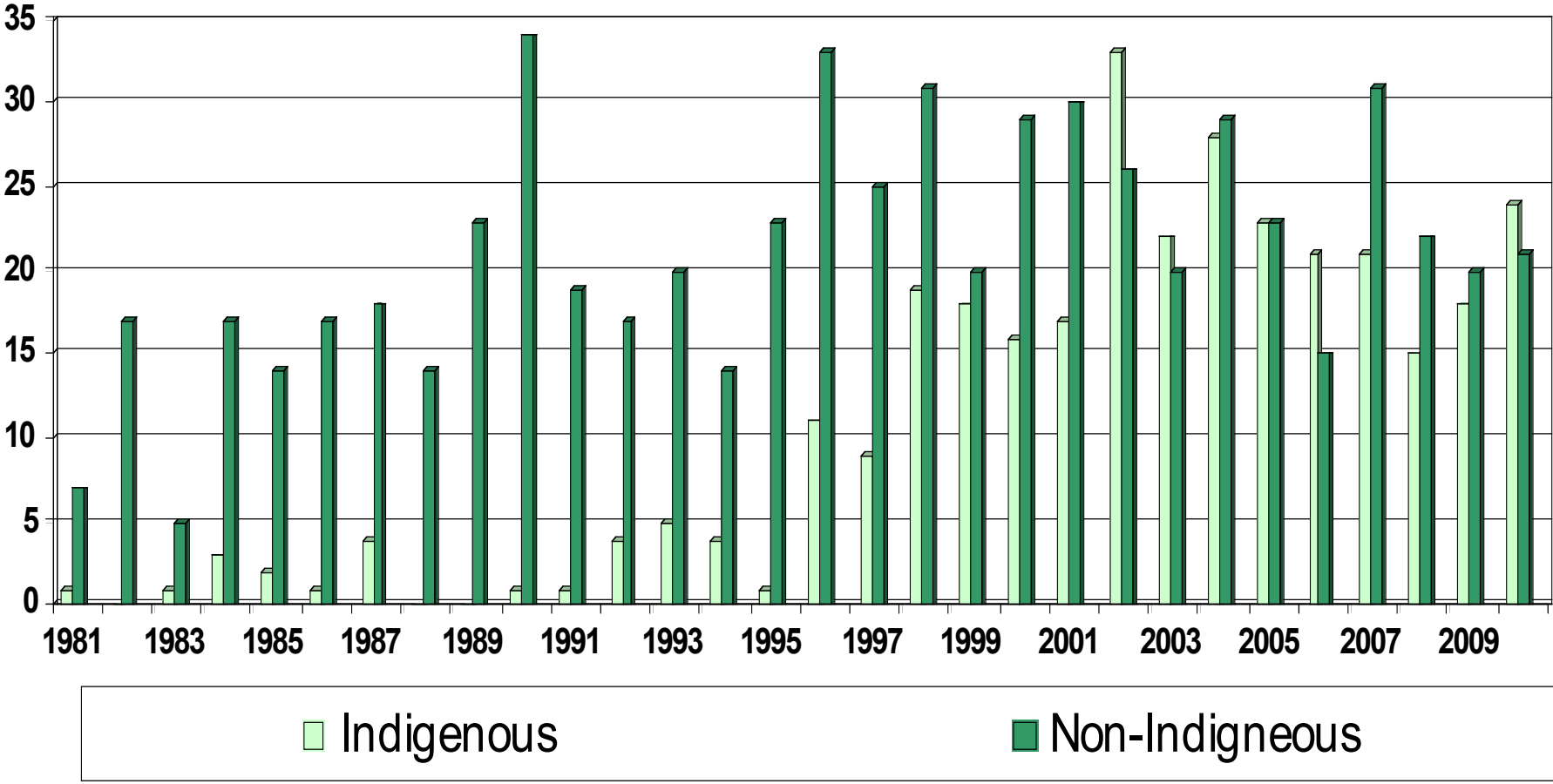




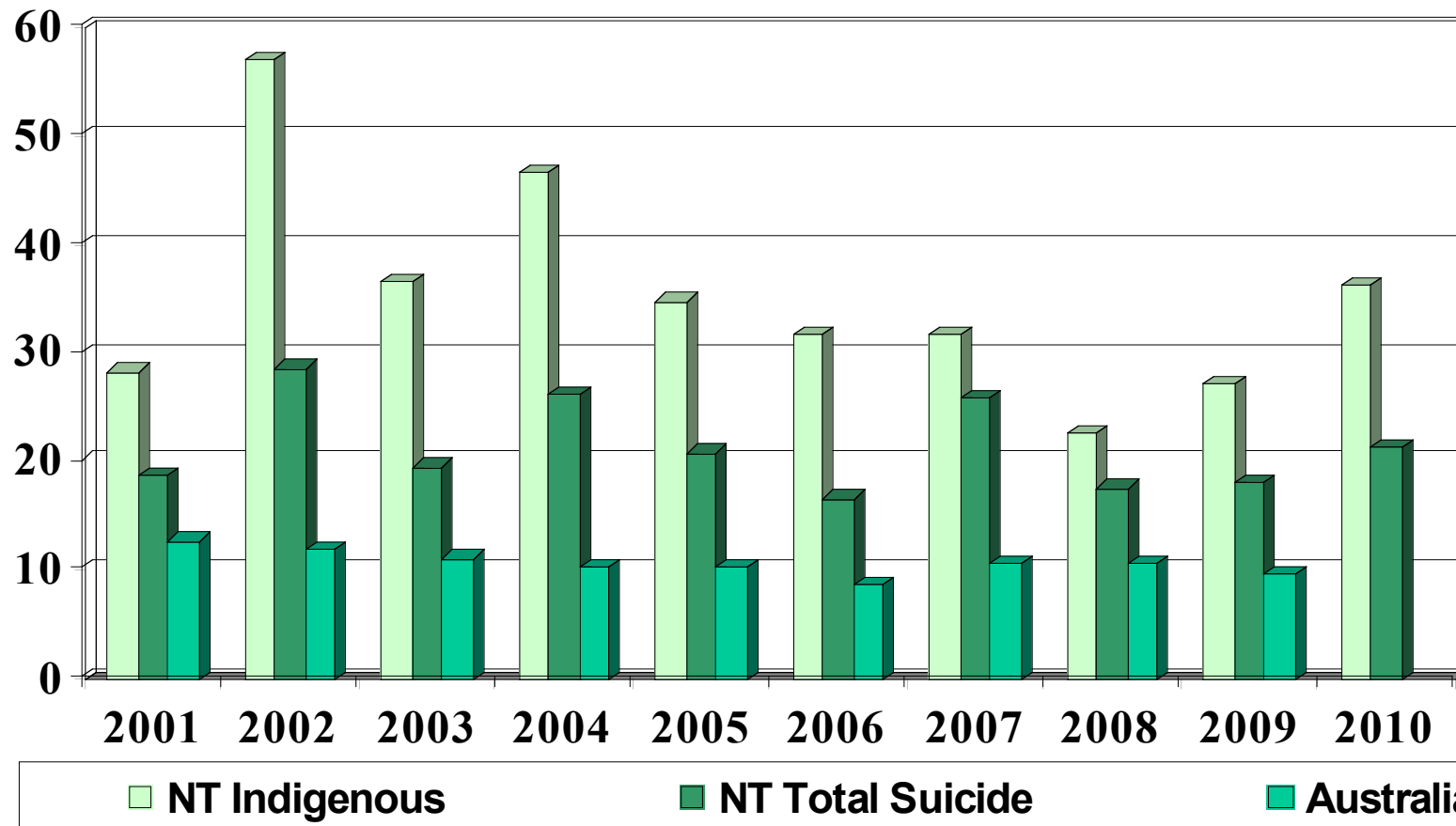

# NT Indigenous suicide numbers compared to non-Indigenous suicide over three decades 1981 – 2010.



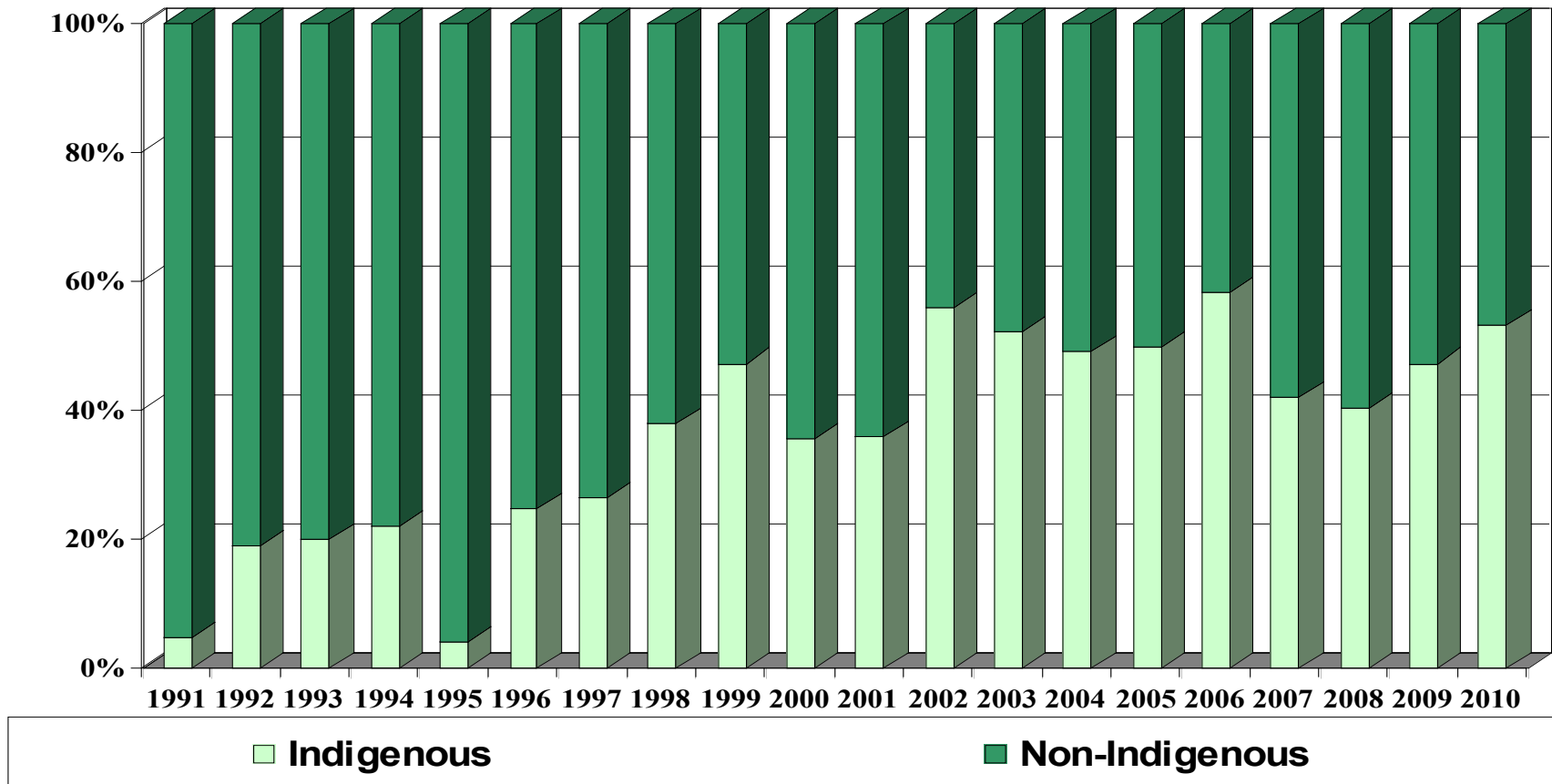

# Northern Territory Indigenous Suicide rates compared to NT Total Suicide rates and Australian Suicide rates per 100,000 2001 -2010.



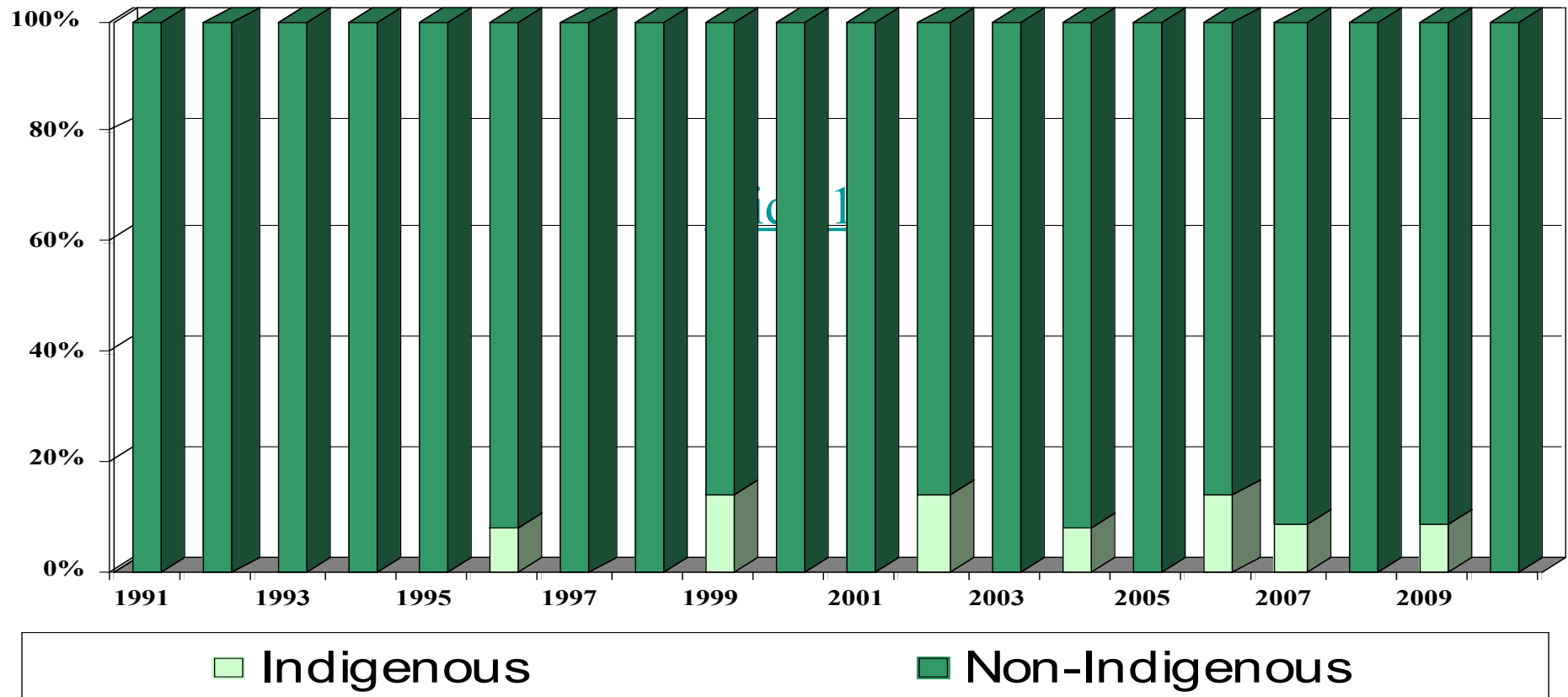

# NT Indigenous Suicide compared to non-Indigenous: Age 45 – 75+ Percentage of total suicides 1991 – 2010.

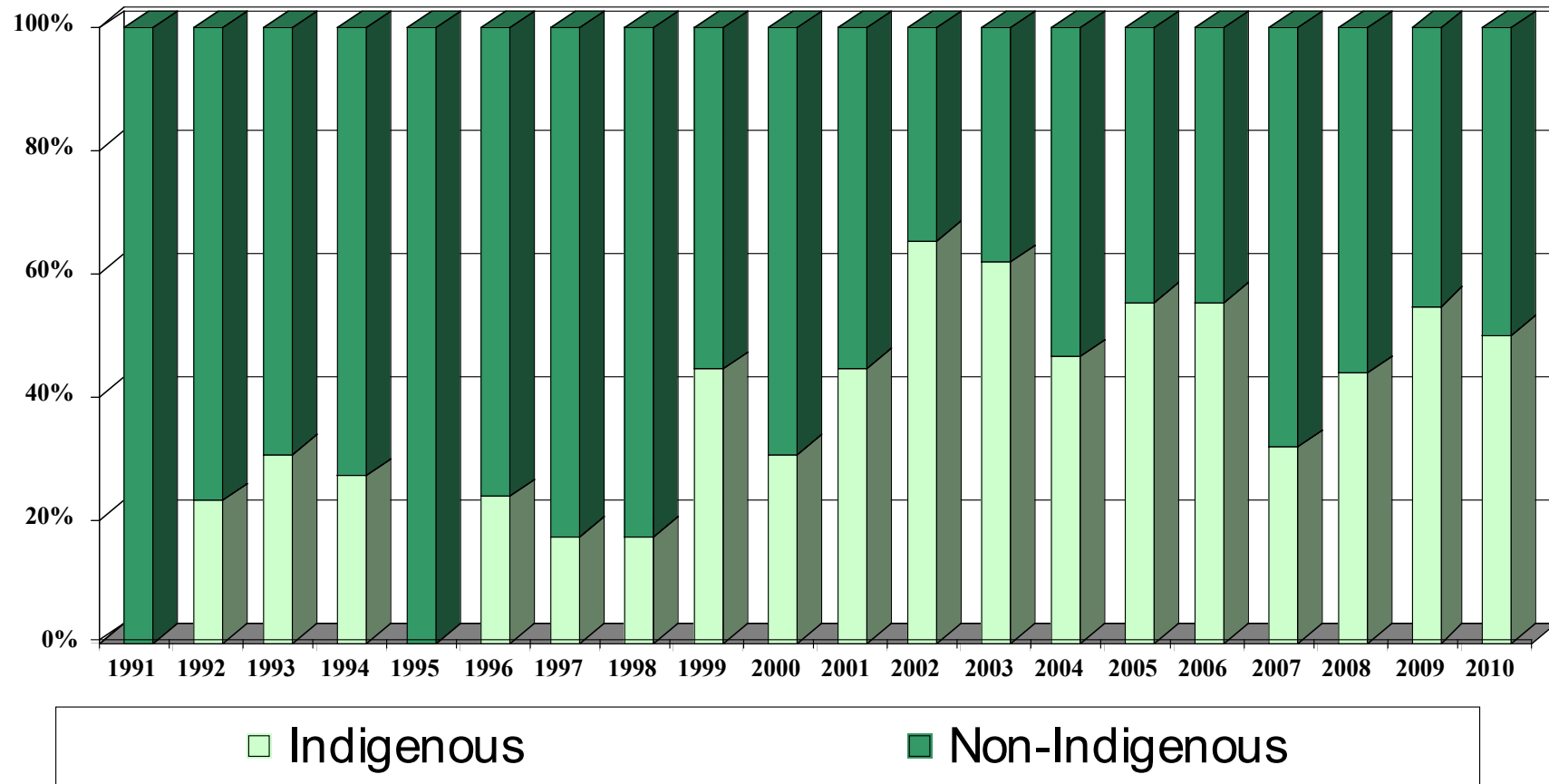

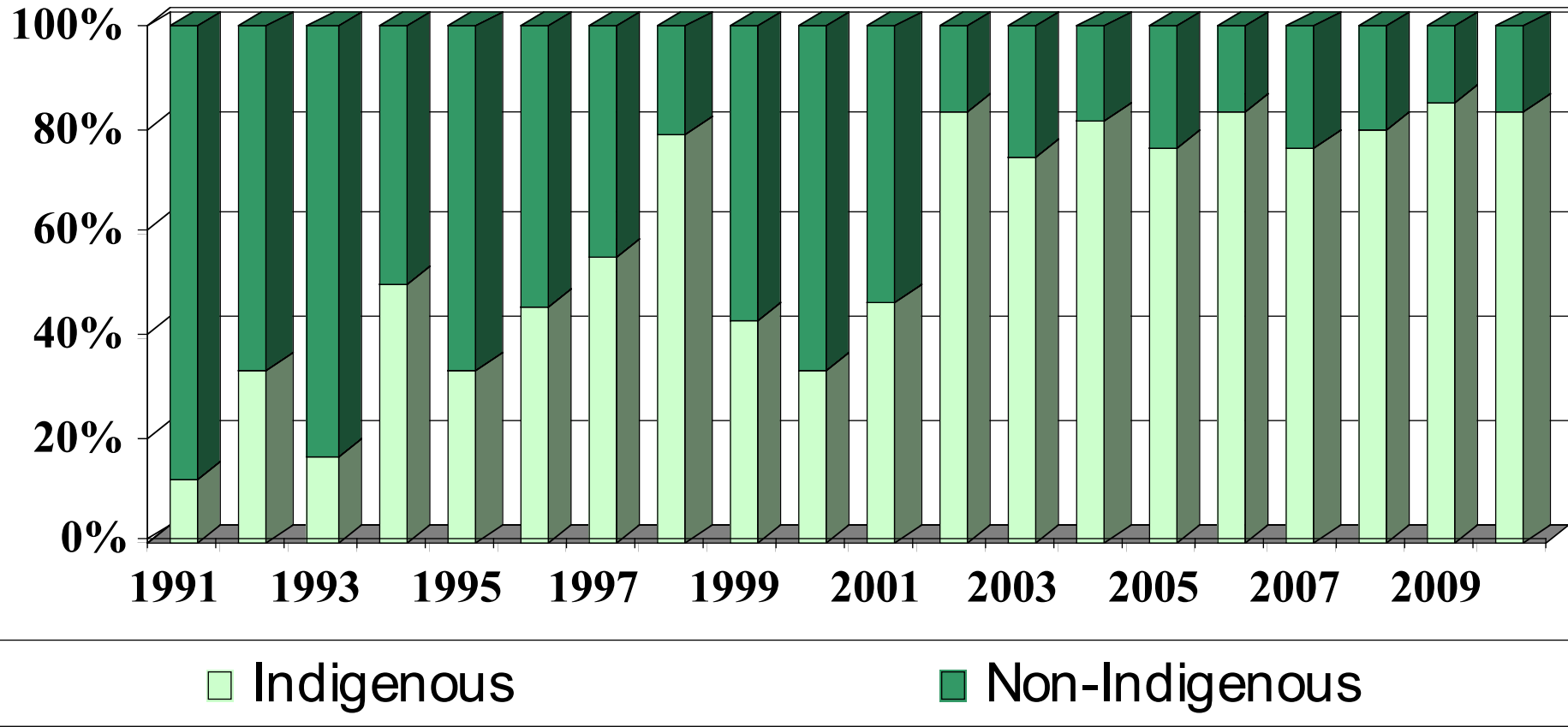

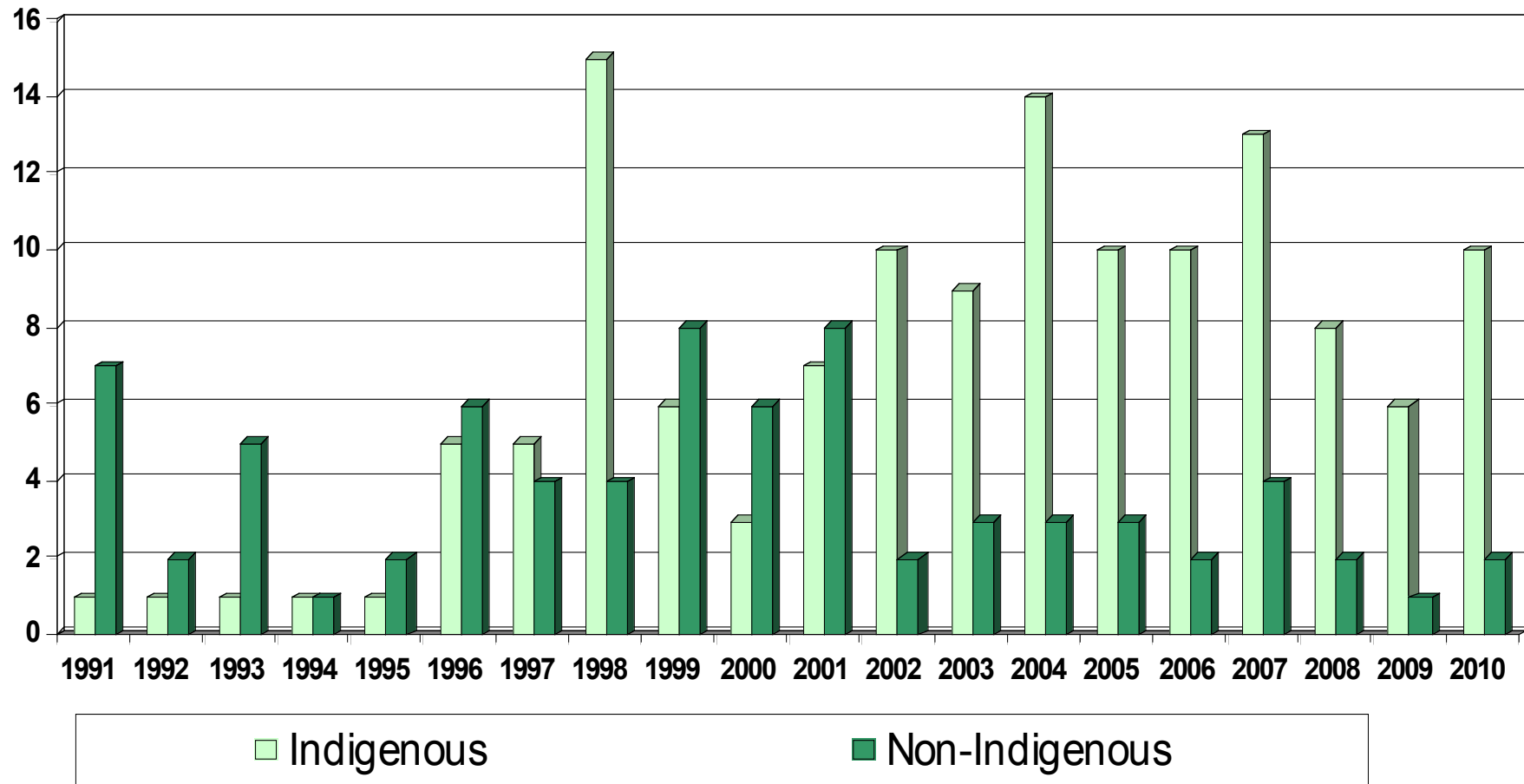

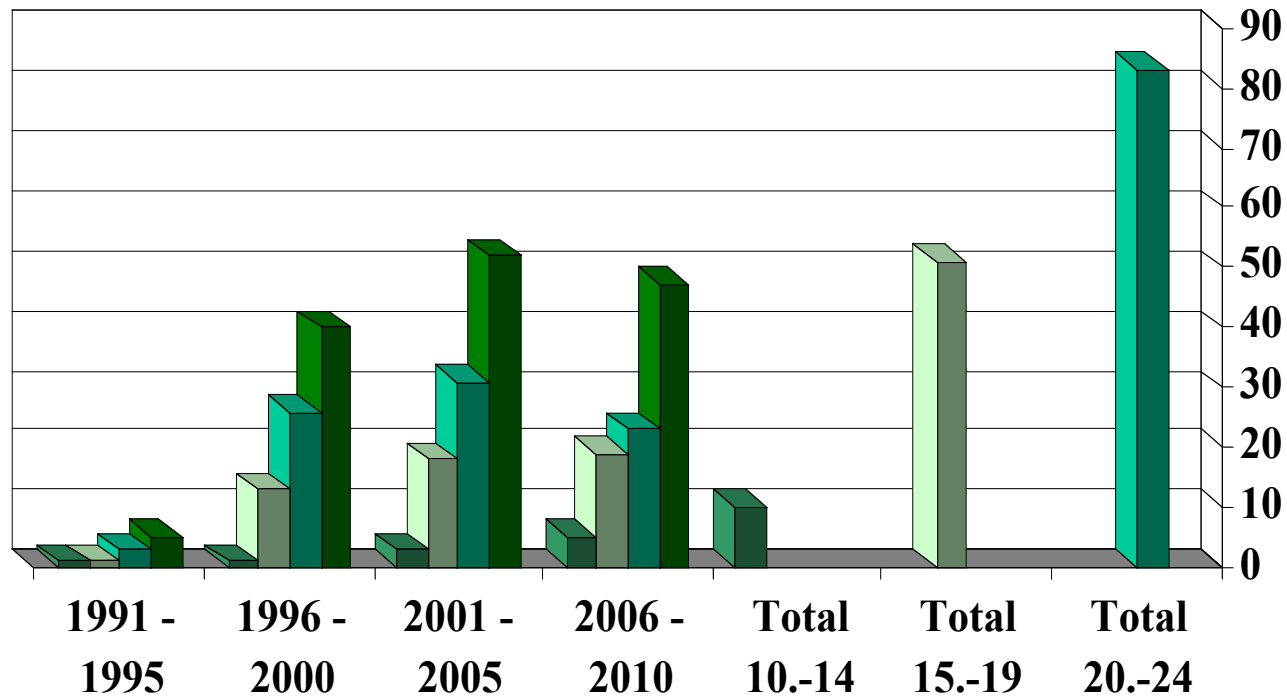

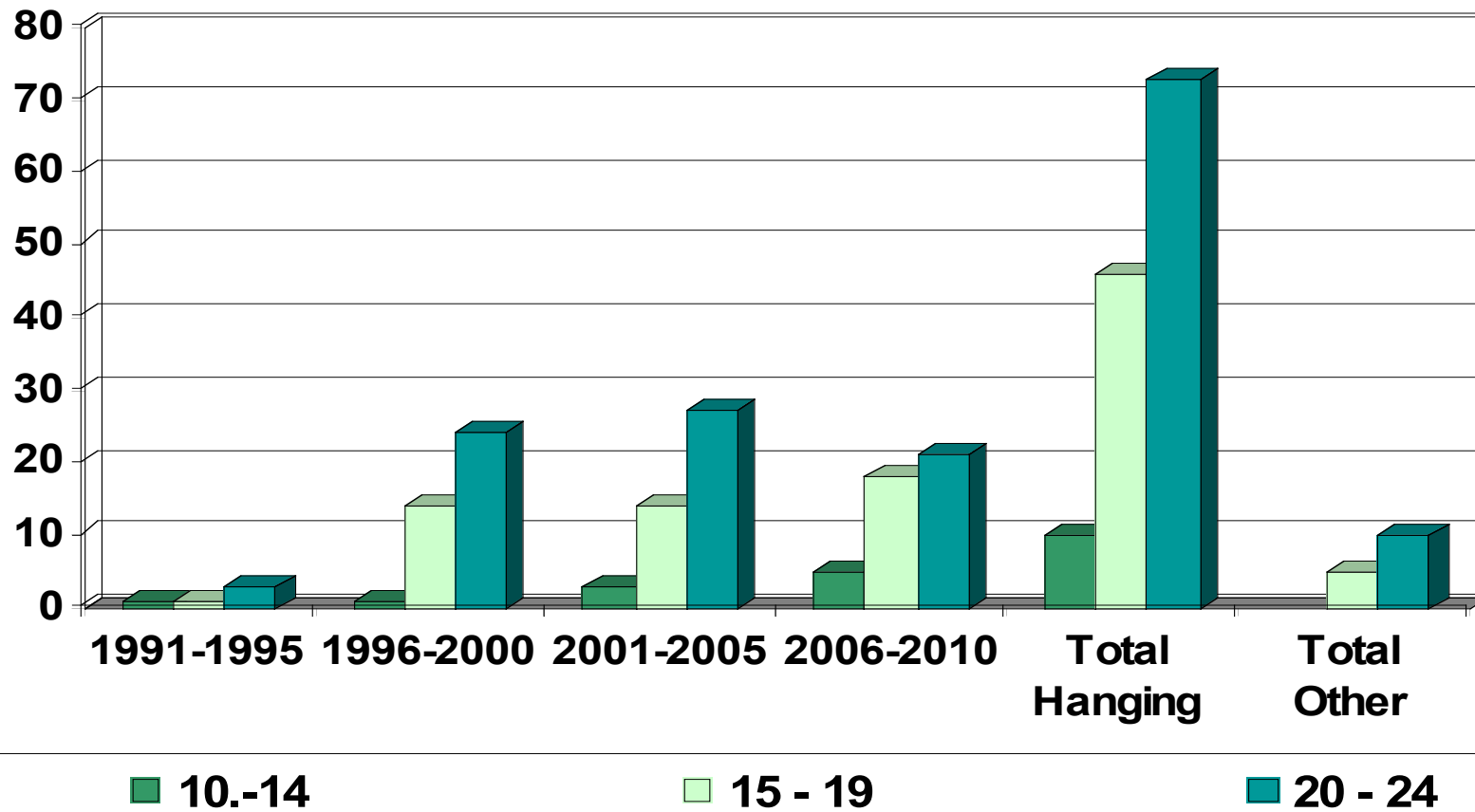


**Northern Territory Indigenous Youth Suicides 1991 – 2010.
